The purpose of this exam is for students to understand the research question, hypotheses, strategies, data, and methods of sociological research papers published in academic journals.

General information

Students should perform the following analyses about **three out of the six papers listed below**. Indicate the main objectives of the papers, including their research questions and hypotheses under consideration. Indicate which data sources and methods were utilized for the investigation. In terms of results, explain the effectiveness of the author(s) at presenting each of the tables and figures included in the paper. Discuss the methodological strategies implemented in the paper that you considered to be novel and interesting. If relevant, discuss portions of the paper that were unclear and did not advance the analysis. If relevant, highlight the methodological limitations identified by the author(s). If a specific paper does not contain data analysis and application of specific methods, explain the overall goal of the study and the logic utilized by the author(s) throughout their discussion.

The document should be on US Letter paper size, one-inch margins, Arial font, size 11, 1.5 line spacing, and a **maximum of 1,500 words**.
